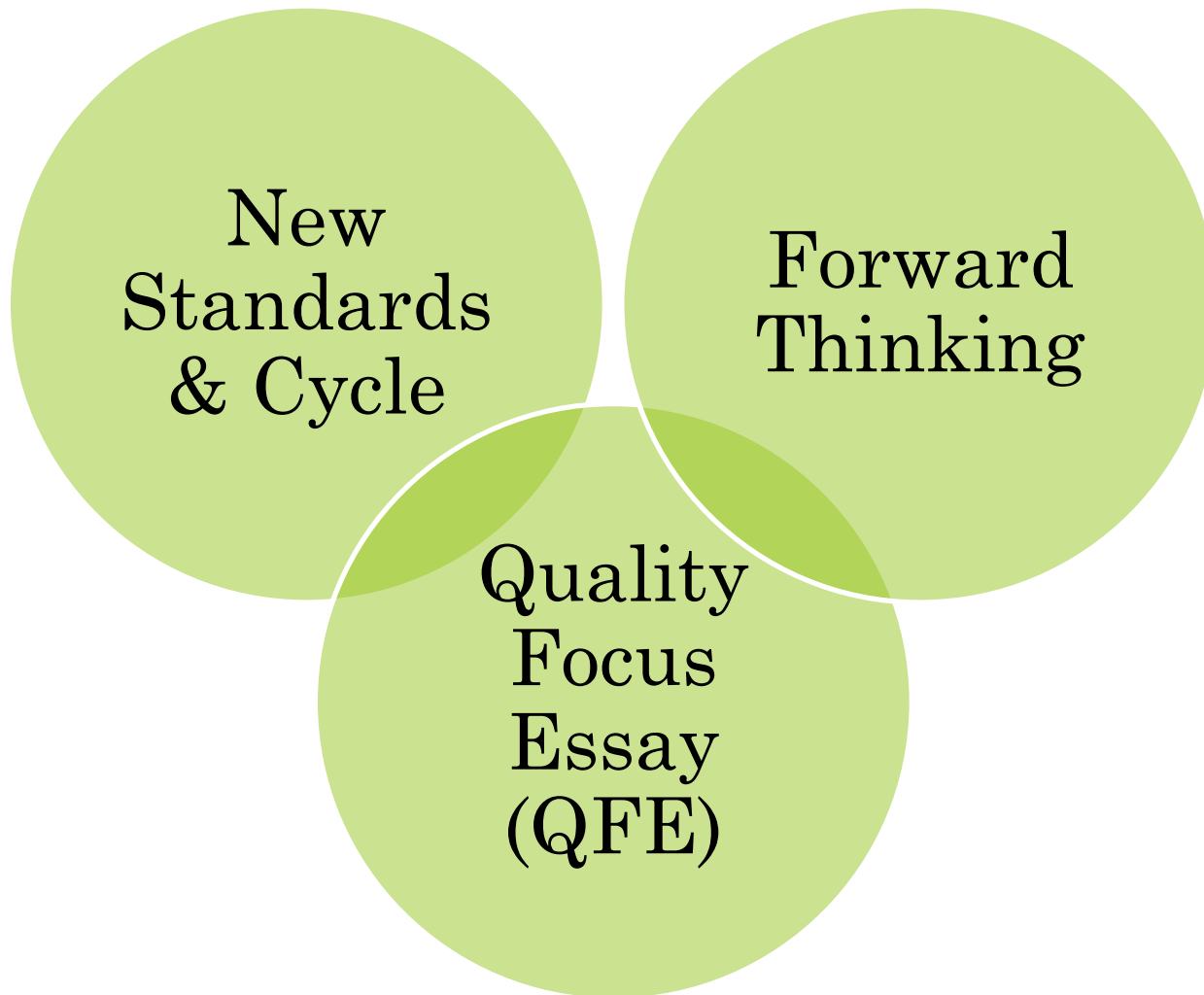

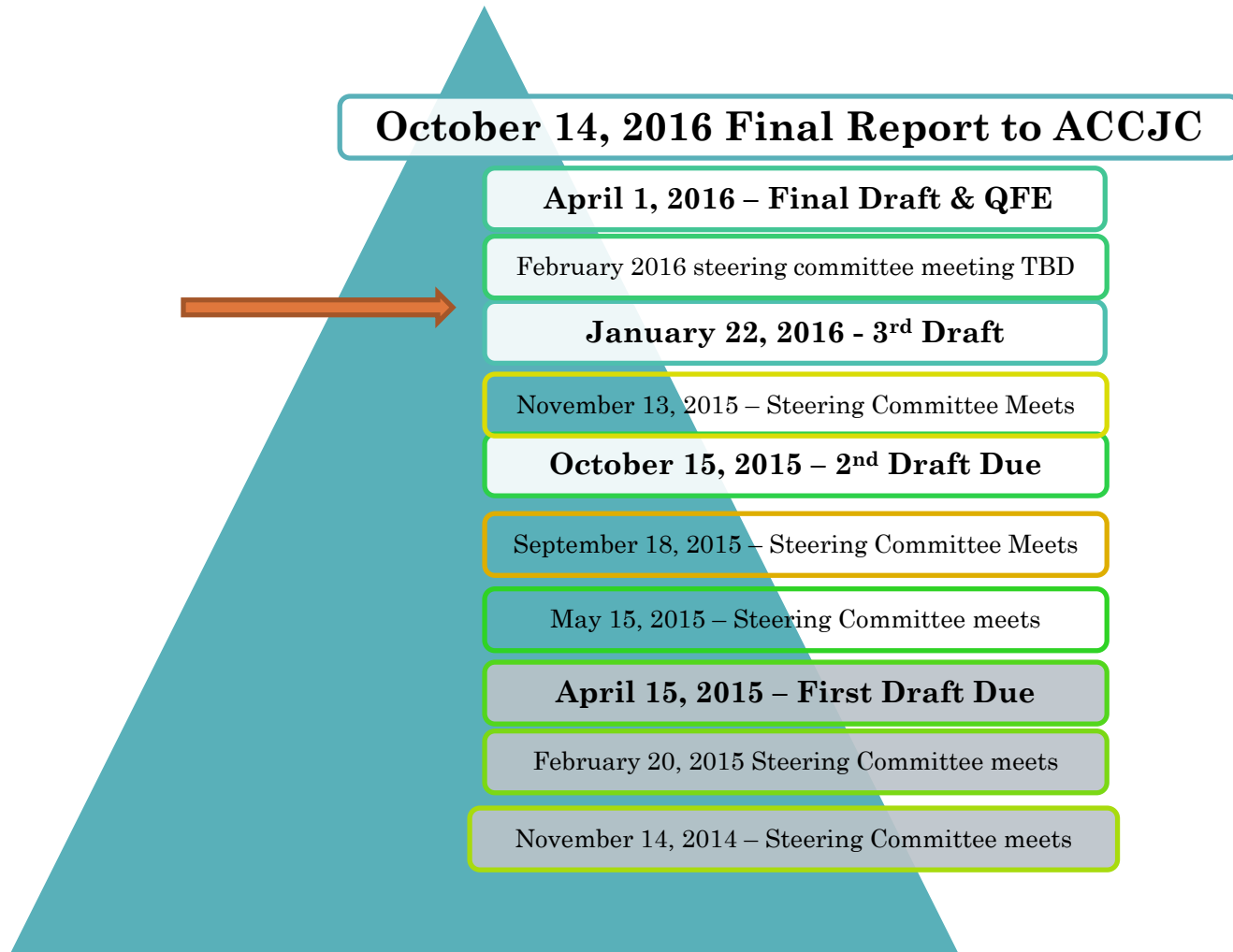
Writing Quality Focus Essay (QFE)
