2026-2027 Financial Aid Disbursement Dates

Notes:

- You must be registered, packaged (awarded aid) and in good academic standing by the disbursement date for a disbursement to occur.
- Late starting classes are counted in your financial aid around the time the classes begin.
- Pell Grant is generally paid in two disbursements per semester (one at the beginning of the semester, the other around the mid-point of the semester).
 - If you pay out of state tuition, you may only receive one disbursement for the semester/payment period.
- **Cal Grant and Student Success Completion Grant (SSCG) funds are disbursed after Census Day each semester.**
 - **SSCG awards are based on the availability of funds.**
- Direct Loans are paid in two disbursements for the loan period – the loan period is usually the academic year (1st at the beginning, 2nd at the mid-point).
- Most other aid is disbursed once per semester (SEOG, Cal Grant, SSCG, Scholarships, etc.).
- There may be additional disbursements made due to changes in your eligibility, such as changes in your enrollment status.
 - You will likely not receive funds on each disbursement date listed.
- A single disbursement of Pell Grant and Direct Loans may be made if the first disbursement occurs after the mid-point of the semester.
- Funds/refunds are sent based on the disbursement preference you select with BankMobile Disbursements, a technology solution, powered by BMTX, Inc. Log on to the [BankMobile Disbursements site](#) for more information. For questions, contact EVC Financial Aid Office.
- **Returning Financial Aid Funds:** you may be required to return financial aid funds if you receive aid and drop prior to the census date for that course(s), and/or if you do not complete any of your courses (withdraw and/or fail courses). The amount of funds to return may vary depending on how much you initially received and when you dropped your courses
