Concurrent Enrollment Program (CEP)

The Concurrent Enrollment Program (CEP) – offered through a partnership between Evergreen Valley College (EVC) and Arizona State University (ASU) – provides a pathway for students to complete an associate degree in nursing through EVC and a bachelor's degree in nursing through ASU simultaneously. Participants are students who meet the EVC and ASU CEP eligibility requirements and have applied to the CEP.

Quick Facts

- EVC and ASU have created a Concurrent Enrollment Program (CEP) for nursing students to simultaneously earn an Associate Degree in Nursing (ADN) and a Bachelor of Science (BSN) in Nursing.
- The EVC - ASU CEP is an educational pathway partnership designed to assist in meeting the National Academy of Medicine's goal to increase the percentage of BSN-prepared nurses.
- CEP students enroll in EVC and ASU classes at the same time.
- EVC courses are taught in the classroom, lab or clinical.
- ASU CEP courses are offered completely online. ASU courses do not require an in-person commitment making work / life / school balance easier to manage.
- BSN-prepared nurses are highly valued by potential employers and CEP graduates are equipped with the knowledge and skills of the new graduate baccalaureate prepared nurses.

ASU Eligibility

To be eligible to join the ASU CEP, students must meet all of the following criteria:

- Be admitted to or enroll in the [Evergreen Valley College associate degree nursing program](#).
- Earn a minimum 3.0 cumulative GPA in the prerequisite courses listed below. Course options at EVC are listed in parenthesis next to each ASU requirement. For options to improve prerequisite GPA, contact ASU's Edson College of Nursing and Health Innovation.
 - First Year Composition I (ENGL 001A)
 - First Year Composition II (ENGL 001B or ENGL 001C)
 - College Mathematics (Options include MATH 021, MATH 025, MATH 061, MATH 062, MATH 066, MATH 071)

Although not required for ASU admission, completion of MATH 063 Elementary Statistics at Evergreen Valley College will satisfy the statistics graduation requirement at ASU.

Key Information

- Students must have a current application in the EVC pool or must already be admitted to the EVC nursing program to be eligible for CEP consideration.
- Students must be admitted to the EVC nursing program to begin ASU CEP courses.
- Students must complete the ASU CEP prerequisite courses noted above with a 3.0 GPA to begin the ASU CEP courses. Additional course grades in traditional nursing prerequisite courses may be included in the GPA, if needed, to meet the 3.0 GPA requirement. *For options to improve the prerequisite GPA or for questions about ASU's GPA calculation, contact ASU's Edson College at asu.cep@asu.edu.*
- Students missing prerequisites can complete transferable courses at the community college or with ASU Online.
- Final determinations of transfer credits will be made by both EVC and ASU. Students with coursework from institutions other than EVC and ASU should have their coursework submitted for official evaluation through ASU's [Transfer Guide](#).
- Credit by exam (AP, CLEP, IB, etc.) may be accepted to fulfill ASU prerequisites

depending on the exam subject/name, date taken and score earned. Please refer to ASU's [Exam Search](#) to determine course equivalency.

- Application and acceptance to ASU is determined after admission to EVC's nursing program.
- Traditional CEP students will begin the ASU CEP courses either the summer prior to EVC's block 1 in fall or in the fall prior to EVC's block 1 in spring.
- A midpoint entry is available for students who have already begun the EVC nursing program.

Advising

EVC advisors are available for application advisement to the ADN program at EVC.

ASU advisors are located in the Phoenix-area and are available to meet via email, Zoom or phone.

Transfer Credits

Students may transfer up to 75 credits to ASU. Students with credits from a four-year, regionally accredited college or university may transfer up to 90 credits to ASU.

ASU Tuition

Financial Aid

Federal regulations require that financial aid can only be disbursed through one college at a time. Depending on each student's unique circumstances, CEP students will file their FAFSA with either ASU or EVC each semester (fall, spring, summer).

Health and Safety Requirements

EVC and ASU have health and safety requirements that must be met prior to enrolling and participating in any clinical experiences. Healthcare agencies require vaccinations, titers, and other healthcare related requirements (examples of these requirements are background checks, CPR, drug and nicotine testing, etc.) These requirements are subject to change per healthcare agency contracts with the educational institution. Students must be compliant with agency requirements prior to and throughout the program.

EVC/ASU Concurrent Enrollment Program (CEP) Model

This is a general/example timeline to apply. Not all students will complete all steps in this order.

	Action	Timeline and Deadlines
Step 1:	Student decides to pursue the CEP through the EVC - ASU partnership.	Ongoing
Step 2:	Student reviews EVC nursing program and requirements, and works with EVC nursing to determine eligibility for ADN program.	Ongoing
Step 3:	Once eligible, student applies to EVC's nursing program during EVC application cycle.	Refer to the EVC nursing website for admission deadlines for each application cycle.
Step 4:	Student connects with ASU Edson College of Nursing and Health Innovation's Recruitment and Admission team, and emails unofficial transcripts to asu.cep@asu.edu for program eligibility (prerequisites and GPA) and next steps. <i>Student may begin ASU application at this time; however, student should wait to pay the ASU application fee until s/he is placed into the clinical nursing program at EVC.</i>	Ongoing
Step 5:	EVC offers acceptance/admission into the ADN program. Student must continue to follow all instructions provided by EVC to retain seat in program.	Refer to EVC's Nursing website and/or offer of admission
Step 6:	Once admitted to ASU, the Edson College of Nursing and Health Innovation verifies all CEP prerequisites and eligibility requirements are complete. If all requirements are met, student will receive a CEP welcome letter from Edson College academic advisor. If requirements are missing, an Edson College advisor will contact student about next steps.	Ongoing until first day of ASU classes
Step 7:	Student enrolls in classes at ASU.	Ongoing until first day of ASU classes
