It is also included in the International (F-1) Student Application Form and must be signed by the applicant upon confirming that **ALL** documents required are included. Once an application is completed, it can be sent either by mail or email to the International Student Program (ISP) office, the mailing and email addresses are shown respectively in the next page. Please note that only **COMPLETE** application will be reviewed, and an admission decision will be made within two weeks upon receipt of a COMPLETE application.

## What You Need To Know as an International Student at EVC

Please take your time and review it carefully

### F-1 Visa Status Maintaining

Once you are issued an F-1 Visa, **you (the student) are responsible for maintaining that status.**

Failure to meet the criteria established by the USCIS could result in being reported “out of status” and in official orders for you to depart the U.S.A. Please refer to the International Student page on EVC’s website for more detailed guidelines.

Also, you **MUST** sign the document “EVC Compliance with USCIS Regulations: The Role and Responsibility of the International Student” upon enrollment.

### Enrollment Requirements

International (F-1) Students are required to enroll as full-time (12 units) students each spring and fall semesters. Intersession and summer are optional.

### Grades Requirements

International (F-1) student must maintain a 2.0 GPA (Grade Point Average) or better.

### Payment Due Dates

All fees must be paid in full before the Census Day (approximately 14 days from beginning of a semester)

### Financial Aid

As an International (F-1) Student, you are not qualified to receive financial aid, college grants/waivers or deferment of tuition.

## Employment Regulations

International (F-1) Students' employment is NOT authorized during the first academic semester at EVC (MIGHT be permitted in the 2nd semester if EVC GPA is above 3.0).

- Off-Campus employment as Post-OPT (Post Graduated Optional Practical Training) must be approved by your designated school official (DSO) for a USCIS application.
- On Campus, employment must be approved by your DSO as employment restrictions relate to your F-1 Visa.

## Health Insurance

International (F-1) Students are required to carry health insurance during their study at EVC. Medical insurance coverage is mandatory to purchase from the school (EVC). Fees included in school tuition.

## Housing Options

Evergreen Valley College does NOT have on-campus housing, however; we can provide a referral for a housing placement company that can assist you. Please let us know if you need it.

## Acceptance into EVC International Students Program

- Acceptance of application materials (documents) does not indicate or guarantee an acceptance to the college.
- Acceptance officially occurs when you have received a Letter of Acceptance and the Form I-20 "Certificate of Eligibility for Non-Immigrant Visa F-1" signed by a designated school official (DSO).
