Financial aid disbursement occurs when EVC credits your student account with financial aid funds. The Disbursement Date is the day EVC credits your account. The REFUND DATE is when funds are sent to you.

2023-2024 Financial Aid Disbursement Dates

Fall 2023, Spring 2024, Summer 2024

Notes:

- You must be registered, packaged (awarded aid) and in good academic standing by the disbursement date for a disbursement to occur
- **Cal Grant funds are disbursed after Census Day each semester**
- Pell Grant is generally paid in two disbursements per semester (one at the beginning of the semester, the other around the mid-point of the semester).
 - If you pay out of state tuition, you may receive one disbursement for the semester/payment period.
- Direct Loans are paid in two disbursements for the loan period – loan period is usually the academic year – (1st at the beginning, 2nd at the mid-point).
- Most other aid is disbursed once per semester (i.e. SEOG, Cal Grant, Scholarships, etc.).

There may be additional disbursements made due to changes in your eligibility (i.e. change in your enrollment status). A single disbursement of Pell Grant and Direct Loans may be made if the first disbursement occurs after the mid-point of the semester.
