

VFC ENROLLMENT GUIDE: RETURNING STUDENTS

1.RE-APPLY TO EVC

- Complete the application at CCCApply if you have not attended more than 2 consecutive semesters
- Be sure to select your Veteran or Dependent status on the application.

2. COMPLETE THE EVC ONLINE ORIENTATION (IF IT HAS NOT BEEN COMPLETED BEFORE)

• Log in to the Self-Service Portal and complete the EVC Orientation available there.

3. CONFIRM VA BENEFITS USAGE

• Inform VFC whether or not you plan to use VA Educational Benefits by calling 408-223-6789 or emailing evcvet@evc.edu.

- You are required to submit the Class Certification Form (CCF) after your plan is approved.
- Students may pay or opt-out of \$2 Student Rep Fee before the term fees refund deadline.

REQUEST OFFICIAL TRANSCRIPTS

- Request official transcripts from all previously attended institutions.
- Students have a one-semester grace period to complete this requirement.

MEET WITH VETERANS COUNSELOR

- Veterans/Dependents not using VA Educational benefits are welcome to meet with the Veterans Counselor for educational planning and support.
