- i. Astronomy classes in the evenings is having difficulty due to lighting on campus being too strong impacts observatory.
 - Suggestions: shielding, strategic hours for lighting on that side of campus
 - Outcome: Vince to investigate and place on discussion or action items.
- b. Antoinette Hererra spoke to request a master list for offices on campus.
- i. Is there a process for assigning offices?
 - For example S130, 131, and 132 are underused can we request that all attempts be made to assign faculty to the building they teach in.
 - Outcome: Assign to October Discussion or Action item

 - If no dollar amount or details were given it was difficult to move forward with the request.

- Discussion was held about wording used, for example "hazardous" and who makes the final decision on whether the situation was deemed hazardous.
- Cindy Bevan asked about how information brought forward in the AURR process was then moved forward to the Team Dynamics page? How is the loop closed to ensure issues are resolved.
- i. Examples: sink traps clogged, mold abatement, etc.
- ii. Response:
 - 1. maintenance evaluates and then either fixes or contracts out the work.
 - 2. VP Alexander states that SFC or VP may be responsible for entering information into Team Dynamics.
 - a. Behavioral aspects, such as paint down a drain, are harder to control and the individual needs a refresher on how to dispose of items.
 - 3. Toby Smtih stated that we contract out the Environmental Health Response and that we may need to develop procedures. This could take 60 120 days for the new procedural manual.
 - a. We need to assess current procedures these issues.
 - Dean Herrera asked when the new building master plan would be available to review because of a chemistry lab being held in Acacia which requires chemicals to be transported from MS3 building – across campus – to Acacia.
- i. Response: Recommended Dean Herrera attend the new facility master plan meeting in October with final report out in March or April. Consultant is working on this now. Rough draft due in October with March 30th deadline.
 - Some examples of completed work included a new soccer field but score board needs to be updated.
