Course: EDIT 010: Computers and Digital Media in Education + All DE

Modalities (3 units)

This course will guide students through implementing instructional technology, including AI-powered tools and adaptive learning systems, into educational environments.

Course: AUTO 132B: Honda Individualized Skills Training (IST) Session B + Fully/Hybrid Synchronous Modalities (1.5 units)
